Dear Parishioners of St. Joseph Parish,

I would like to thank everyone who has assisted me in any way during my two months here. The Knights and Ladies of St Peter Claver who responded to support for property, church and rectory clean-up; 18 parishioners who have become the altar guild; the two new count teams for the offertory collection; the Pastoral Advisory and Finance Councils; those involved with ministries for the Sunday Mass. To all I owe a debt of gratitude.

One weight has been our Property & Liability Insurance for 2023-2024. This past Thursday I was able to make your first payment of \$42, 047.98 which was due by April 30. The third and final payment was due on June 30th. A plan for the remaining amount due will have to be arranged.

For those who use the weekly envelopes, the number of envelopes/collections per month has decreased. As I suggested last Sunday, since the building fund envelope has been removed, the amount that went into that envelope needs to be added to the regular Sunday envelope since it all went together in the end to pay bills. My example, last week, was if one put \$10 in the weekly offertory envelope and \$10 in the building fund, the offertory envelope could receive \$20. Remember the parish did not have current permission for a building fund. A building fund is for a specific contract project, for a specific time period, for a specific cost, and the Bishop has given permission. Once the project has been completed the permission for a building fund is rescinded. The current church roof project is being paid by insurance and is not an official building fund project. Remember when we are away the Church, operation goes on. Making up offertory from when we are away greatly helps the parish. Electronic giving is another way to assist the parish on a consistent basis. "God will not be outdone in generosity."

St. Joseph Parish will always have a special place in my heart. I look forward to watching your growth under Fr. Pat LaPointe.

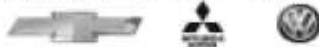
