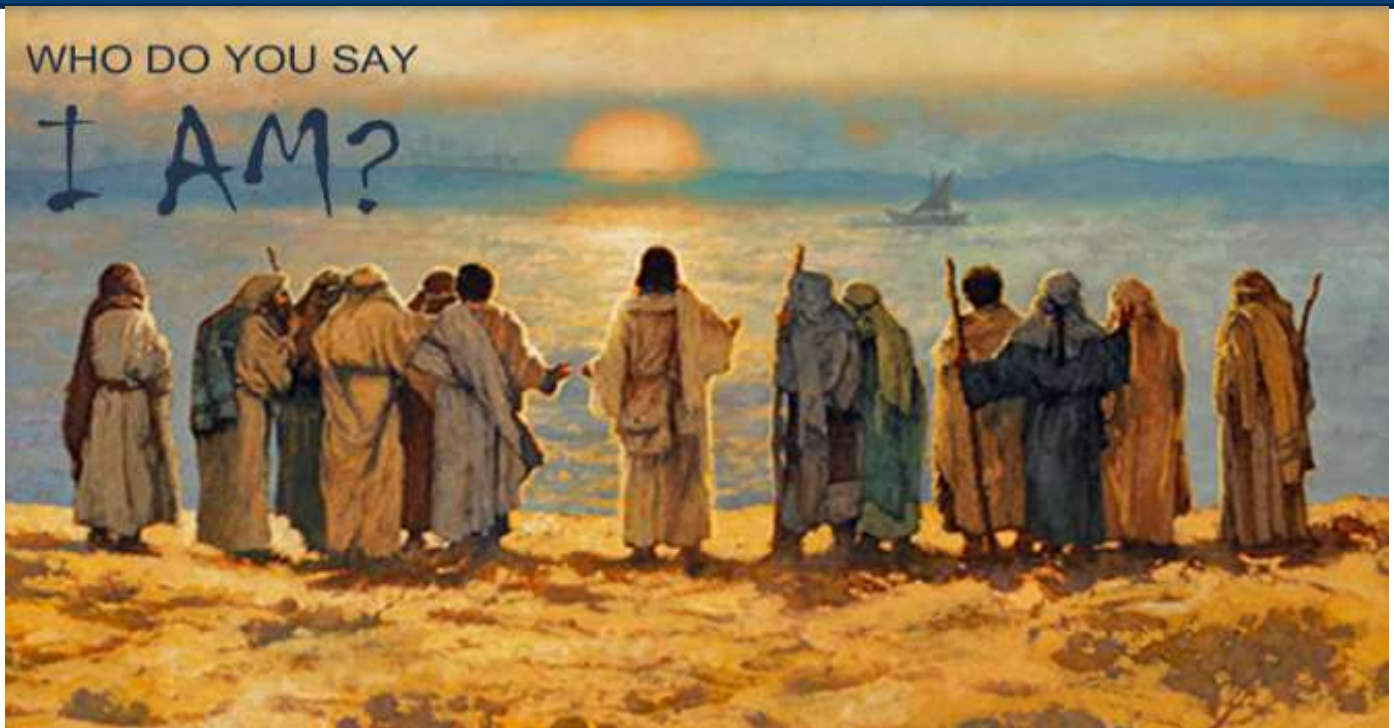

A Message from Fr. Pat..



Trinity House is a residential transitional ministry that serves homeless senior men. Case management and counseling services are provided. Upon acceptance into the ministry, an initial program plan is developed, and goals formulated. A monthly review evaluates the progress of these goals. One goal each resident must have is to save money and be financially responsible.

Residents of Trinity House are required to pay a monthly fee for programming and subsistence. Chores, and participation in house meetings and monthly dinners are required. The goal of Trinity House is that each individual gains the knowledge, skills and abilities that will eventually allow them to live independently in a secure and permanent home.

This is the property on our parish grounds which we have been trying to rent for years, and have not been successful, even after performing renovations to the building.



Having been a landlord before, I found it to not be a pleasant experience, and personally I do not think it is appropriate for a non-profit organization to rent to a for profit company. Instead, we should look for a way to use our properties to more closely align with our mission here at St. Joseph parish; looking for a charitable group that we could partner with, just as we have partnered with the medical clinic here at our parish.

When I attended the retirement luncheon for Monsignor Hunt, at the table I was sitting, I expressed my desire to find a charity that could use our building and have the same relationship that we have with the medical clinic. Deacon Ray Aguado approached me and told me about Trinity House. Trinity House is sponsored by the diocese and Bishop Bill is the president of the charity. After consulting our parish advisory council, I have decided to begin a relationship with Trinity House to allow three men to live in our building. I will also be reaching out to other groups to help support us financially in this endeavor, which allows us to offer our building to these men looking to change their lives.
